# **OVERVIEW** Snapper Grouper Commercial Sub-Committee

# 1. Review of Commercial Issues in the 2016-2020 Vision Blueprint (Attachments 1a and 1b)

In 2015, the Council approved the 2016-2020 Vision Blueprint for the Snapper Grouper Fishery in the South Atlantic. The Vision Blueprint set the Council's plan to prioritize and address issues in the snapper grouper fishery. Council staff will present a summary of Vision Blueprint priorities for the commercial sector, as well as a summary of progress made toward those priorities.

### Sub-Committee Action: None.

### 2. Discussion of Current Commercial Issues and Initial Prioritization

In June 2024, the Council formed the Snapper Grouper Commercial Sub-Committee and tasked it with reviewing the Vision Blueprint and developing topics that require further consideration, noting the following list as examples of potential topics:

- 2 for 1 SG1 policy
- Permit leasing
- 225 Permit policies
- Regional management
- Examination of items from FL Commercial Fishing Summit
- Different permit usage (e.g. "permit stacking", others)
- Ways to increase trip efficiency (e.g. day-based trip limits)
- Infrastructure
- Environmental Equity and Justice concerns
- Climate change concerns

**Sub-Committee Action:** Develop a recommended list and preliminary prioritization of topics requiring further consideration. Recommend next steps in addressing the listed topics.
