The SSC meeting was called to order at 1:00 pm, as scheduled. The agenda was adopted without change and the minutes of the April 2012 meeting were adopted without further comment or changes. Regarding the SEDAR schedule, the SSC discussed the fact that it is likely that MARMAP will not be able to provide updated fishery independent (MARMAP/SEAMAP/SEFIS) black sea bass age data if the update is moved to 2013. Changing the schedule will likely cause problems with data timeliness and accuracy, especially with the funding cuts MARMAP has been faced with.

SSC RECOMMENDATION:

The SSC reviewed and discussed the three main actions proposed in the Shrimp Amendment 9 document and provided the following comments:

Action 1. Specify criteria that triggers states' ability to request a concurrent closure of the overwintering white shrimp stock in the adjacent EEZ during severe winter weather.

SSC comments: The SSC felt it difficult to provide advice on the minimum temperature thresholds proposed in Alternatives 2-4 without further information on mortality associated with each of the temperature values proposed. Some committee members felt that more complete data and analyses are needed before the SSC can properly review this action. In particular, members identified the need for more information on the relationship between shrimp mortality rates and water temperature. It was also suggested that it might be more useful to look at monthly instead of annual CPUE data since there is a lot of seasonal variability in water temperatures and cold weather events would most likely happen in the winter. Concerns were also raised regarding the source and location of temperature measurements that would be used to determine if the threshold were met. The SSC requests these data and analysis be provided for review at the Oct SSC meeting.

Action 2. Modify the process for a state to request a concurrent closure of the overwintering white shrimp stock in the adjacent EEZ during severe winter weather.

SSC comments: The SSC has no specific advice or comments given the administrative nature of this action.

Action 3. Revise the overfished status determination criteria (B_{MSY} proxy) for the pink shrimp stock.

SSC comments: If there are no immediate consequences for leaving the *status quo* in place the SSC recommends that the Council wait to see the analytical results of the new Stock Synthesis 3 (SS3) assessment model that has been used for shrimp in the Gulf. Besides providing a more detailed description of shrimp population dynamics, SS3 allows more explicit integration of environmental parameters into the analysis. The committee suggests we take this opportunity to also evaluate biological reference points for the other shrimp species. A presentation on application of Stock Synthesis to shrimp stocks and consideration of assessment possibilities for Atlantic shrimp stocks is planned for the October 2013 SSC meeting.

Note: need to check to make sure we are not confusing B_{MSY} with MSST (Minimum Stock Size Threshold) throughout the Shrimp Amendment 9 document.

In summary, the Committee felt that if there is no critical timetable to be met the Council should wait until the SSC evaluates new assessment possibilities for shrimp before proceeding with approval of Amendment 9 to the Shrimp FMP. This would also allow evaluation of more complete data and analyses needed to complete scientific advice on alternatives associated with Action 1.
