SUMMARY REPORT FROM THE SNAPPER GROUPER COMMITTEE MEETING Charleston, SC September 15th-17th, 2009

The Snapper Grouper Committee met on September 15th-17th, 2009 in Charleston, SC.

1. Presentations

The Committee received the following presentations: *Oculina* Update (Kim Iverson), Status of Red Snapper Interim Rule (Dr. Jack McGovern), Red Snapper Rebuilding Projections (Dr. Erik Williams), Impact of Recent Regulations/Closed Area Evaluations (Dr. Nick Farmer), Economic Impacts to the Commercial Sector From Proposed Actions in Amendments 17A and 17B (Dr. Jim Waters), and Presentation of Economic Impacts to the Recreational Sector From Proposed Actions in Amendments 17A and 17B (Dr. Jong Lamberte).

2. Amendment 17A, Rick DeVictor, SAFMC Staff

Council staff presented the alternatives in the amendment, in addition to the Snapper Grouper and Law Enforcement Advisory Panels' recommendations. The Committee reviewed closure area maps that staff developed based upon the Law Enforcement recommendations.

The Committee discussed the implications, including those in terms of economic and social effects, from retaining the current F_{MSY} proxy and from specifying a new one based upon recommendations from the SEDAR Review Panel and SSC. The Committee decided to retain the preferred alternative that would specify a F_{MSY} proxy according to the most recent SEDAR/SSC recommendation; this level is equivalent to that at the $F_{40\%SPR}$ level. In addition, the Committee directed staff to combine actions that would specify *optimum yield* and the *rebuilding strategy* as both actions achieve the same purpose of specifying the rebuilding goal by choosing a fishing mortality rate. The Committee developed accountability measures for red snapper and discussed the problems with monitoring the rebuilding biomass with self-reported discard data.

The Committee also reviewed ten proposed alternatives, including the preliminary analyses investigating the biological effects and feasibility of each, that have come forward from the Snapper Grouper Advisory Panel and public since the June 2009 Council meeting. Among these alternatives where ideas to specify days-at-sea, allocate the red snapper ACL by state and sector,

reduce bag limits and specify vessel limits, and specify a tag system for the recreational sector. The Council added an alternative for public hearings that would allocate the red snapper ACL as non-directed removals to the three sectors, would establish a designated snapper grouper bottom fishing zone in the South Atlantic, and would require real-time electronic reporting and VMS for those permitted to fish in the area. The details of this alternative are outlined in Motion #44. The Committee decided to add an alternative that would analyze the use of circle hooks for all snapper grouper species at the northern end of the closed blocks and another alternative that would require circle hooks throughout the entire EEZ for the snapper grouper fishery. The Council approved Amendment 17A for public hearings. The details of direction to staff and the team are provided in the motions.

3. Amendment 17B, Rick DeVictor, SAFMC Staff

Council staff presented the alternatives in the amendment, in addition to the Snapper Grouper and Law Enforcement Advisory Panels' recommendations. The Committee reviewed maps that displayed the closure beginning at approximately the 240 ft depth contour that staff developed based upon the Law Enforcement recommendations. The Committee reviewed an action that would specify the golden tilefish allocation. The Council approved Amendment 17B for public hearings. The details of direction to staff and the team are provided in the motions.

4. Amendment 18 - Kate Quigley, SAFMC Staff

Council staff presented the alternatives in the amendment, in addition to the Snapper Grouper and Law Enforcement Advisory Panels' recommendations. The Council approved Amendment 18 for public hearings. The details of direction to staff and the team are provided in the motions.

5. Amendment 20 - Kate Quigley, SAFMC Staff

Council staff presented the alternatives in the amendment, in addition to the Snapper Grouper and Law Enforcement Advisory Panels' recommendations. Staff will revise the program review. The details are provided in the motions.

6. Comprehensive ACL Amendment, Rick DeVictor, SAFMC Staff

Rick DeVictor presented guidance from National Standards Guidance 1, 3 and 7 in terms of either designation species as Ecosystem Component species or removing species from the Fishery Management Unit (FMU). The Council directed staff to add various alternatives that would either designate some species as Ecosystem Component species or remove some from the FMU. The specific alternatives are outlined in the motions. These alternatives would investigate the ratio between landings in state and Federal waters, the level of commercial landings, and state regulations. The Council added an action that would investigate changing the current commercial trip limit of 1,000 lbs for greater amberjack.

7. Fishery Independent Monitoring Workshop

The Committee discussed the workshop to be held in November, and selected members of the fishing community to participate in the workshop.

8. Other Business

South Carolina members of the Council raised concerns over the level of commercial landings in Special Management Zones. The Council decided to add an action to Amendment 18 that would change the regulations in these areas. Alternatives include limiting harvest to all users to the bag limit and for NMFS to delegate management authority of management zones to the respective states.

Mandatory species ID training VMS Real time text message reporting of catch (B1s and B2s)

A subset of each sector would be selected by the SEFSC to bring in red snapper for biological sampling.

If reporting requirements are violated, the permit would be revoked.

Permit issuance:

The NMFS SERO shall issue permits in the initial or any subsequent permit year by lottery devised and operated by the agency.
