## SUMMARY REPORT FROM THE SNAPPER GROUPER COMMITTEE MEETING

## Charleston, SC September 14<sup>th</sup>-16<sup>th</sup>, 2010

The Snapper Grouper Committee met on September 14<sup>th</sup>-16<sup>th</sup>, 2010, in Charleston, SC.

#### 1. Presentations

The Committee received the following presentations: *Oculina* Update (Kim Iverson) and SSC Report from their August 2010 meeting (Dr. Carolyn Belcher).

2. Red Snapper Management Actions/Analysis of Closure Alternatives as a Result of Change from Red Snapper Benchmark – Dr. Nick Farmer, SERO Staff

The Council decided that a Regulatory Amendment through framework action and an environmental assessment is the proper level of analysis in order to analyze a change in regulations from those actions proposed in Amendment 17A. There is a 15 to 45 day comment period on the proposed rule and a maximum of a 90 day comment period on CZMA consistency, though states may respond to the CZMA determinations before 90 days. The Committee provided guidance to staff in terms of the range of alternatives to consider in the amendment. The Committee provided the following two alternatives to act as bookends for the analysis:

- (1) The combination of the red snapper closure and the smallest possible spatial closure to close snapper grouper fishing.
- (2) The combination of the red snapper closure and the closure in Amendment 17A but possession and retention would be allowed a portion of the year.

(Note: The prohibition of possession and retention of red snapper would most likely be continued based on the preliminary results of the draft assessment report)

The Committee provided latitude to staff to develop other alternatives as necessary as bounded by these two alternatives.

## 3. Amendment 18 – Kate Quigley, SAFMC Staff

Council staff presented the alternatives in the amendment. The Committee decided to split Amendment 18 into 18B (FMU Extension Action and designation of EFH for Snapper Grouper in Northern Extension Area) and 18A (rest of actions). The Committee approved a motion to take Amendment 18A to public hearings. The details are provided in the motions.

### 4. Amendment 20 – Kate Quigley, SAFMC Staff

Council staff presented the alternatives in the amendment. The details are provided in the motions.

## 5. Comprehensive ACL Amendment, Rick DeVictor, SAFMC Staff

Council staff presented the alternatives in the amendment. The Committee discussed the SSC's ABC Control Rule, determined that it is a work in progress and that it should not be included in the Comprehensive ACL Amendment as an alternative at this time. The schedule is to approve the amendment for public hearings at the December Council meeting. The details are provided in the motions.

## 6. Amendment 21 (Comprehensive Catch Shares) – Kate Quigley, SAFMC Staff

Council staff presented the alternatives in the amendment. Scoping meetings will be held in January/February 2011. The details are provided in the motions.

## 7. Amendment 22 (Long-Term Red Snapper Management) – Rick DeVictor, SAFMC Staff

Council staff presented the alternatives in the amendment. The Committee approved the range of alternatives developed by the IPT but added the following alternatives:

- (1) red snapper endorsements
- (2) bag limits
- (3) size limits
- (4) actions pertaining to different gear types
- (5) seasonal closures

Scoping meetings will be held in January/February 2011. The details are provided in the motions.

8. Amendment 24 (Black Grouper and Red Grouper) – Rick DeVictor, SAFMC Staff

Council staff presented the alternatives in the amendment. The Committee moved the actions pertaining to black grouper to the Comprehensive ACL amendment as that amendment considers species groupings for a shallow water grouper complex. The Committee decided to retain red grouper in this amendment as a rebuilding plan is required. The Committee chose a preferred rebuilding period of 10 years for red grouper, but recognized that they will review the annual yield and corresponding economic analysis for a shorter rebuilding period in the future. Scoping meetings will be held in January/February 2011. The details are provided in the motions.

9. Regulatory Amendment 9 (Black Sea Bass, Vermilion Snapper, Gag, and Greater Amberjack Trip Limits and Sea Turtle Release Gear Changes) – Dr. Jack McGovern, NMFS-SERO

The Committee added various trip limit alternatives, including ones higher than the included in the amendment. The Committee moved the gear changes to the Comprehensive Ecosystem Based Amendment 2 as NOAA GC advised the Committee that gear restrictions of this type are not covered under the framework.

#### 10. Other Business

The Comprehensive ACL Amendment contains modifications to the current wreckfish bag limit. NOAA GC mentioned that non-wreckfish permit holders would not be able to retain the bag limit caught fish. The Committee advised staff to investigate this further for Council discussion in December.
