

#### PENAEID SHRIMP




- Increasing number of reports and observations of food shrimp (*Penaeid sp.*) in Virginia Waters
- VIMS has documented shrimp from surveys since the 1970's.
  - Juvenile Trawl Survey annual catches appear to be increasing
  - NEAMAP reported 382 lbs in one 20 minute trawl east of CBBT 9/18.
  - VMRC was approached by industry leadership about starting a fishery.











# JUVENILE FISH & BLUE CRAB TRAWL SURVEY VIVIS





#### HOW DO SHRIMP RECRUIT TO CHESAPEAKE BAY?

- Most likely via larval transport from NC spawners
- Warmer waters, along with favorable tides, winds, and currents
- Nutrient rich conditions in the bay allow for rapid growth
- Shrimp leave creeks and rivers and migrate offshore as waters cool in the fall






### BACKGROUND – VA TRAWLING REGULATIONS

§ 28.2-314. Trawl nets and drag nets prohibited; sale of fish; penalty (1992)

Except as may be provided in § 28.2-315...

# § 28.2-315. Fishing with trawl net within three-mile limit; license fee (2009)

- Commission may issue licenses to trawl within the three-mile limit.
  - Cape Charles to MD Border: Nov-Aug
  - Cape Henry to 36°40': Oct 1 -May 1
  - 36°40' south to NC Border: All Year
  - Experimental Area (red): Dam Neck Rd to NC Border (~89 sq miles)



### CREATING A NEW FISHERY

Permits: Special Experimental Fishing Permits

Who: 2017: 1 Boat. 2018: 2 Boats. 2019: 6 Boats

When: VA Beach: September 1 to December 31.

Eastern Shore: November 1to December 31. (2019)

Area: VA Beach: South of Dam Neck Annex

Eastern Shore: Ocean Side: Cape Charles to VA/MD Line (2019)

Gear: 16' Beam Trawl w/ approved BRD. Tow Duration ≤ 30 minutes.

Monitor: VMRC Observers aboard vessel for trips


Reporting: Call-in Daily Shrimp Harvest and Bycatch Estimate. Mandatory Monthly Reporting.



# FISHING GEAR 16 FT BEAM TRAWL




#### 2019 FISHING AREA



## 2018 RESULTS (OCT 23 - DEC 12)


- 35 fishing trips
- 13 observer trips over 11days
  - 71 trawls observed for catch see map
- Catch Statistics
  - \*Confidential
- Bycatch Statistics N=22
  - Bycatch Ratio: 0.46 lbs: 1 lbs shrimp



### RESULTS – CATCH COMPOSITION

- Observer Trips through Nov 30 (N=11)
- Other Fish are non-regulated species (N=22)

### 2019 RESULTS TO DATE (OCTOBER 1 TO NOVEMBER 22, 2019)

- VA Beach: 72 trips, 8 observed. Eastern Shore: No Activity
- Total Shrimp: 52,558 lbs
- Total Bycatch: 10,324 lbs



### **GOALS FOR 2019 AND BEYOND**

- Maintain Experimental Fishery Status for 2019
- Allow for a small increase in permits each year
- Develop participation eligibility requirements limited entry
- Maintain present stipulations on Gear, Season, Reporting
- Continue Observer Coverage
- Improve Marketing



### **ISSUES**

- Managing Federal Waters
- SAFMC Shrimp FMP extends only to North Carolina
- How do should larger vessels with larger nets fishing off Virginia be managed?
  - More Bycatch
  - More Shrimp competing against the small state fishery
