OVERVIEW

Protected Resources Committee

The Committee will approve of minutes from March 2017 meeting and the agenda for the September 2019 Committee meeting.

1. Council/NMFS Memorandum of Understanding (MOU) – (Attachment 1)

Description: In January 2015, NMFS released a policy directive on ESA/MSA Integration. The directive implemented recommendations from the ESA Working Group, which was convened by the Marine Fisheries Advisory Committee (MAFAC) and the Council Coordination Committee (CCC) to make recommendations on how to improve the involvement of regional fishery management councils in the ESA section 7 consultation process. In March 2016, the Council approved the Integration Agreement between the South Atlantic Council and SERO PRD in regard to coordination with and involvement of the Council in Section 7 consultations. Council staff will review the current Integration Agreement.
