For the reasons set out in the preamble, 50 CFR part 622 is proposed to be amended as follows:

PART 622--FISHERIES OF THE CARIBBEAN, GULF OF MEXICO, AND SOUTH ATLANTIC

1. The authority citation for part 622 continues to read as follows:

Authority: 16 U.S.C. 1801 et seq.

2. In § 622.190, revise paragraphs (n)(1)(i), the first sentence of (n)(2)(ii), and add paragraph (n)(3) to read as follows:

§ 622.193 Annual catch limits (ACLs), annual catch targets (ACTs), and accountability measures (AMs).

(n) * * *

(1) * * *

(i) If commercial landings for yellowtail snapper, as estimated by the SRD, reach or are projected to reach the commercial ACL of 1,596,510 lb (724,165 kg), round weight, and 80 percent of the combined commercial and recreational ACL (as specified in paragraph (n)(3) of this section) which is 2,430,000 lb (1,102,229 kg), round weight, then the AA will file a notification with the Office of the Federal Register to close the commercial sector for the remainder of the fishing year. - (ii) If recreational landings for yellowtail snapper, as estimated by the SRD, exceed the recreational ACL, then during the following fishing year recreational landings will be monitored for a persistence in increased landings, and if necessary, the AA will file a notification with the Office of the Federal Register to reduce the length of the recreational fishing season and the recreational ACL by the amount of the recreational ACL overage, if the species is overfished based on the most recent Status of U.S. Fisheries Report to Congress, and if the combined commercial and recreational ACL as specified in paragraph (n)(3) of this section, is exceeded during the same fishing year. * * *
- (3) The yellowtail snapper combined commercial and recreational ACL is 3,037,500 lb (1,377,787 kg), round weight.
