

Background

The new regulations for king mackerel established in CMP Amendment 26 became effective on May 11, 2017, including updated commercial trip limits for the Atlantic Southern zone.

Each Atlantic Southern Zone season has a quota and specified trip limits:

- SC/NC line to the Flagler/Volusia county line:
 - o 3,500 lbs year-round
- Flagler/Volusia county line to Miami-Dade/Monroe county line:
 - Season 1 (March 1- September 30): 50 fish for March 1-31; 75 fish for April 1-September 30
 - Season 2 (October 1 end of February): 50 fish until February 1, then will increase to 75 fish if <70% of the Season 2 quota has been landed.

Some fishermen on the Florida east coast have expressed concern about the new trip limits, especially the 50-fish limit for March 1-31 from the Flagler/Volusia line to the Miami-Dade/Monroe line. Additionally, at their April 2017 meeting, the Mackerel Cobia Advisory Panel recommended that the Council review the March trip limit or consider a different trip limit for north of the Volusia/Brevard line.

At the September 2017 the Council approved alternatives and directed staff to begin work on a framework amendment to adjust the trip limits. A framework amendment would not require action by the Gulf Council.

Actions in this amendment

• **Action**: Modify commercial trip limits for king mackerel harvest in the Atlantic Southern Zone.

Purpose and need statement

Purpose for Actions

The purpose is to modify the commercial trip limit for Atlantic king mackerel in the Atlantic Southern Zone.

Need for Actions

The need is to provide anglers with a trip limit sufficient to support fishing activity while constraining harvest to the ACL and providing for year-round access.

Proposed Actions and Alternatives

Action 1. Modify the commercial trip limit for Atlantic king mackerel:

Alternative 1 (No Action): The commercial trip limits for Atlantic king mackerel:

- Season 1
 - March 1 March 31
 - North of the Flagler/Volusia line: 3,500 lbs
 - South of the Flager/Volusia line: 50 fish
 - April 1 September 30
 - North of the Flagler/Volusia line: 3,500 lbs
 - South of the Flager/Volusia line: 75 fish until 75% of the Season 1 quota is met, and then the trip limit is 50 fish until Sept 30
- Season 2
 - October 1 End of February
 - North of the Flagler/Volusia line: 3,500 lbs
 - South of the Flager/Volusia line: 50 fish
 - Starting February 1 through the end of February, if less than 70% of the Season 2 quota has been met, the trip limit increases to 75 fish.

Alternative 2: Adjust the commercial trip limits for Atlantic king mackerel in the Atlantic Southern Zone for Season 1:

- Season 1
 - o March 1- March 31
 - North of Flagler/Volusia line: 3,500 lbs
 - South of Flagler/Volusia line: 50 fish
 - o April 1 September 30
 - North of Volusia/Brevard line: 3,500 lbs
 - South of Volusia/Brevard line: 75 fish until 75% of the Season 1 quota is met, and then the trip limit is 50 fish until Sept 30

Alternative 3: Adjust the commercial trip limits for Atlantic king mackerel in the Atlantic Southern Zone for Season 1:

- Season 1
 - o March 1- March 31
 - North of Flagler/Volusia line: 3,500 lbs
 - South of Flagler/Volusia line: 75 fish
 - o April 1 September 30
 - North of Volusia/Brevard line: 3,500 lbs
 - South of Volusia/Brevard line: 75 fish until 75% of the Season 1 quota is met, and then the trip limit is 50 fish until Sept 30

Alternative 4: Adjust the commercial trip limits for Atlantic king mackerel in the Atlantic Southern Zone for Season 1:

- Season 1 (Mar Sept)
 - o North of Volusia/Brevard line: 3,500 lbs
 - South of Volusia/Brevard line:
 - March 1- March 30: 50 fish
 - April 1 September 30: 75 fish until 75% of the Season 1 quota is met, and then the trip limit is 50 fish until September 30

Discussion

The following figures illustrate the commercial trip limit modifications for each alternative.

Alternative 1 (No Action):

Season 1

March 1st – September 30th


Trip limit 3,500 lbs

Flagler/Volusia line

March 1- 31: 50 fish
Starting April 1, trip limit is 75 fish. When
75% of the Season 1 Quota has been landed,
the trip limit is 50 fish.


Gulf and Atlantic Stock Boundary

October 1st – End of February




Season 1 March 1- March 31



Season 2 October 1- end of February




April 1- September 30




Alternative 3:


Season 1 March 1- March 31



Season 2 October 1- end of February




April 1- September 30




Alternative 4:
