EXECUTIVE DIRECTOR'S REPORT JUNE 2018

The Council's priorities for 2017/18 are included as Attachment 3b in TAB 11, Executive Finance Committee. Detailed information on the status of each FMP/Amendment and upcoming meetings in contained in the Council Follow-Up (Attachment 3a in TAB 14, Executive Finance Committee). There will be a number of new items that need to be accommodated within our list of priorities, so we will need to discuss them and get guidance on modifications to the Council's priorities.

Also, in Executive Finance we will be looking at a draft 2018 budget (see Attachments 2a and 2b in TAB 14, Executive Finance Committee) that includes the items approved by the Council in December 2017 to reduce our costs in 2018. We expect level funding in 2018 (same base level as 2017) plus approximately \$100,000 additional funding for regulatory reform. We may know our final 2018 funding level at the June 2018 meeting, and we need to get the Council's guidance on activities (see Attachments 2c and 2d in TAB 14, Executive Finance Committee). In the interim, we will be operating under the draft 2018 budget.

Charlie, Mark, and I will be attending the Council Coordinating Committee (CCC) meeting May 22-24, 2018 and a report will be available at the June Council meeting. During that meeting, the three of us are planning to meet with our counterparts from the New England and Mid-Atlantic Councils to talk about how we address species (data collection, assessment, and management) as they continue to shift their distribution northwards. This is an effort Michelle Duval initiated with the Mid-Atlantic Council's leadership.
