SUMMARY REPORT - SAFMC Visioning Workshop June 8, 2015 Key West, FL

Final Review and Discussion of Draft Strategic Goals – *Science, Management, Communication, & Governance* – and Vision Blueprint Glossary

Staff presented the revised draft objectives, strategies, and actions for each strategic goal. Council provided staff guidance on edits to the language of the document, revisions and additions to the draft strategies and actions, and overall format of the documents. Council made suggestions to re-word the introductory paragraph to indicate that Science, Management, Communication, and Governance are four strategic focus areas and that the Visioning Project is a public process that is stakeholder driven. For the strategic goals, the following suggestions were made:

- Science strategic goal: add language under objective 5 (ecosystem and habitat considerations) related to improving understanding of the impacts of offshore energy development.
- Communication strategic goal: add a new strategy to consider outreach on the linkage between habitat and fisheries and an outreach tool for polling the public about needs for habitat improvements as it relates to the snapper grouper fishery.

Council also reviewed the Vision Blueprint Glossary and suggested adding the terms bycatch limit or bycatch allowance and spawning Special Management Zone to the glossary.

Review of Public Input Promotional Materials and Strategies

Staff presented the draft promotional flyer that will be mailed to all federal snapper grouper permit holders (commercial and for-hire), sent out via e-mail to the Council's contact lists and port meeting participants. Council suggested changing out the images on the flyer and clarifying the public input options for the webinars/comment stations and to include accepting hand written comments via mail. Council reviewed the web comment form that will be posted on the Council's website to collect online comments on the draft Vision Blueprint.

Planning Discussion for Public Input & Schedule

Staff provided an overview of a draft schedule for public input in July 2015 that will include a series of webinars and webinar/comment stations. The federal register will be sent the week of June 8th. The draft schedule will be finalized by June 19 and is listed below.
